The Corps was established based on a vision to provide for Nigeria a safe haven of roads that will enhance the sanctity of human lives










IN AFRICA

Africa has the highest road fatality per 100,000 population. This is contributed disproportionately by member States and the situation is of serious concern in Sub-Saharan region of the continent.




Road traffic fatalities per 100 000 population

MECHANISMS FOR DRIVING INTO THE FUTURE

Based on **Safe Systems Approach** on road safety, the FRSC has envisioned a Nigeria where road traffic crashes result in **NO DEATH**



INNOVATIONS SINCE 2014 TO DATE

While sustaining and improving on previous programmes that have advanced road safety in the country, a number of new innovations have been implemented to enhance accelerated actualization of the Corps vision.

The following are some innovative schemes executed from 2014 to date:


1 SPEED LIMITER ENFORCEMENT

The deployment of Speed Limiting Devices (SLDs) on commercial vehicles is based on the safe systems approach

The implementation of the policy on SLD has brought about visible reduction in traffic fatality in Q1, 2017 to date

There is an assurance that a greater degree of reduction in fatalities will be recorded at the end of the year arising from increased SLD use

3 NATIONAL POST CRASH INITIATIVE

An initiative, National Post Crash Community Care Initiative (NPCCCI) was introduced to equip first responders at crash scenes with professional and sound skills on how to effectively attend to victims of crash along their communities.



4 SPECIALIZED DRIVERS LICENCE CENTRES

Four (4) specialized Drivers License Centres were created in **Suleja, lagos, Port Harcourt** and **Calabar** to address deficiencies in acquisition on Drivers License by drivers of Tankers and Trailers in the country

5

ESTABLISHMENT OF ROAD SIGNAGE PLANT

An indigenous road signage plant has been established to produce world class standard road signs to meet the local needs of the country

6 TANK FARMS DEPLOYMENT

To address Tanker/Trailer road deaths and crashes, 169 Officers of the Corps were deployed to the various Tank Farms nationwide



7 PERMANENT VEHICLE INSURANCE NUMBER

A digitalized-online verification system was introduced on vehicle insurance to eliminate fake auto insurance in the country.



7 TAKE –OFF OF NaRSAC

Implementing Safe Systems Approach on road safety requires a Strategy. The Nigeria Road Safety Strategy (NRSS) has been endorsed, however, execution of NRSS led to the inauguration of the National Road Safety Advisory Council (**NaRSAC**)




IMPACTS AND RESULTS


Implementation of new road safety innovations have positively impacted on the country projecting Nigeria's image in good light in a number of ways

Certified an ISO 9001:2008 QMS organization in 2013, standards have been sustained and improved upon to earn a recertification for the next three (3) years (2016-2019)


